Request for Information - ATISN 10146

I wrote to you on 5 February regarding your request for information. You asked for documentary evidence that would obligate anyone travelling in a private conveyance to participate in a traffic census operation, whether assisted by the local constabulary or not. You also asked that if any lawful obligation does exist, it does not violate or impinge on your right to travel in a private conveyance, or violate any of your rights under ECHR or UNUDHR.

Having investigated the matter, I can confirm that we do not hold on record any of the information you have requested. I can advise, however, that the document DMRB TA11/09 'Traffic Surveys by Roadside Interview' is adopted for use in Wales. http://www.standardsforhighways.co.uk/dmrb/vol5/section1/ta1109.pdf. I trust that this will be helpful to you in understanding the context of roadside interviews.
