Request for Information – reference 10148

Thank you for your request which I received on 1st February 2016.

The Freedom of Information Act only provides a right of access to information held by the public authority which receives the request. That is, we only have to consider providing the information we hold that falls within the parameters of the information you have described.

On that basis I believe your request to be for:

- All recorded information relating to the grant support for building works at 62, Station Road, Queensferry, Flintshire as part of the Deeside street frontage enhancement grant scheme.
- Any recorded information relating to 62, Station Road, Queensferry, Flintshire since 2013.
- Any recorded information relating to the following companies.
 - Vibrant Resourcing Limited
 - Enbarr Enterprises Limited
 - Enbarr Recruitment and Training
 - Ossian Limited.

I am enclosing the information which you requested, which is described in the enclosed list.

It is worth noting that the Deeside Shop Frontage Enhancement Grant Scheme is administered by Flintshire County Council, although funded through the Welsh Government's Vibrant and Viable Places Programme. The only information we therefore hold on the scheme would only be related to financial claims made by the Council to Welsh Government. All details relating to the administration of grants made to property owners would be held by Flintshire County Council.

Any information released under the Freedom of information Act 2000 or Environmental Information Regulations 2004 will be listed in the Welsh Government's Disclosure Log.
