ATISN 10172 – Splott University Settlement

Thank you for your request which I received on 5 February 2016 about the proposed demolition of Splott University Settlement. You asked for:

- Cadw's initial assessment of the Old College Building made during 2015.
- A copy of the assessment of the building made at the time of the resurvey of the Splott community.

A copy of the initial assessment made by the Welsh Government's historic environment service (Cadw) in April 2015 is enclosed.

Having checked our records I can confirm that there is no assessment on file from the time the resurvey of the Splott community was completed on 8 April 1997. I understand that this is not unusual because such assessments tended to only be produced for those buildings that were proposed for listing. Assessments were not typically produced for those buildings that were not considered to be listable because of the resource intensive nature of the task due to the significant number of buildings involved.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.
