## Request for Information – ATISN 10357

Thank you for your request for information which I received on 8 April 2016. In your request you asked for asked for information on the operation of the safety van cameras and the number of prosecutions / fixed penalties to offenders. In particular you asked:

- 1. Is every vehicle approaching the van photographed, or does the operator photograph specific vehicles where an in-vehicle offence (seatbelt, mobile phone) is believed to be committed?
- 2. Is the detection of in-car offences restricted to those vehicles detected speeding in the first place, or are they a separate operation and procedure?
- 3. How is the DVD evidence analysed to identify drivers committing those in-car offences?
- 4. Since mobile phone and seatbelt offences have been targeted by safety camera vans and how many fixed penalty notices and / or prosecutions have been issued?
- 5. In the same period how many speeding offence fixed penalty notices and / or prosecutions have been issued from safety camera van evidence?
- 6. Are drivers' detected committing in-car offences offered an alternative to a fixed penalty notice / prosecution, such as attending an awareness course?
