ATISN 10342 Information on Welsh Government and Homelessness

Further to my e-mail of 5 April 2016 acknowledging your request for information, I am now able to provide you with the information you have requested. I do not appear to have received a response to my request for clarification of the timescales you wished the information to cover, so I am providing information covering the term of the current Welsh Government, i.e. from April 2011 to the end of the last financial year.

I have set out below our response to each question.

1) What are the guidelines and laws that the Welsh Government makes regarding homelessness?

In April 2015, the Welsh Government brought into effect Part 2 of the Housing (Wales) Act 2014. It contained new duties on Local Authorities to help prevent and relieve homelessness. The scope of the legislation ensures everyone is given help to find housing solutions if they are at risk of homelessness, with Local Authorities required to help people to prevent or relieve their homelessness. 3) How much has the Welsh Government spent on the issue of homelessness?

We have awarded the following amounts under our Homelessness Grant programme over this period, which funds a range of projects which help to prevent homelessness and find accommodation for homeless people:

```
2015/16 - £11,331,000
2014/15 - £6,431,000
2013/14 - £8,481,000
2012/13 - £7,150,000
2011/12 - £7,321,000
```

Preventing homelessness is also a core objective of our Supporting People programme, which helps people find and keep a home and to live as independently as possible. Within the programme, funding spent on people who are homeless is as follows:

```
2015/16 - £14,114,270
2014/15 - £14,000257
2013/14 - not available*
2012/13 - not available*
2011/12 - not available*
```

Whilst the sums above reflect the allocation of support specifically for people who have been homeless and are now living in the community, the Programme also helps people with a wide range of problems which can place them at risk of homelessness, such as those with mental health problems or substance misuse problems, people suffering domestic abuse, and young people leaving care.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
