I wrote to you on 28 April following your request for information under the Freedom of Information Act 2000, where you asked for;

- The total annual cost of all smoking control and smoking cessation related activities and projects (salary, consultancy, advertising, research, research grants, publications, IT, equipment etc) for the last 5 years, broken down by year and by category of spend.

The Welsh Government holds information within the scope of your request, which I have attached at **Annex A**.
