Request for Information – ATISN 10445

I wrote to you on 18 May regarding your request for information. Between 2010 and 2015 (in each year) you asked for information relating to damage caused by potholes on the routes managed by the Welsh Government, specifically:

The number of compensation claims made by motorists for damage to their vehicles and how many claims were successful. You also asked the amount the Welsh Government has paid out in compensation to motorists for each year during the same time period.

I can confirm we hold information relating to your request which is enclosed in the table at Annex A of this letter. Please note that the figures also include other carriageway defects. To distinguish pothole defects from all other carriageway defect figures would mean consulting historic files to establish whether the claim was in reference to a pothole or not and would likely take over 24 hours of time to locate, retrieve and extract the information. (The appropriate limit specified for central government set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 is £600, this represents the estimated cost of it taking over 24 hours).

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
