Request for Information – ATISN 10475

I wrote to you on 2 June regarding your request for information. You asked for information relating to Swansea County Council; Judicial Review – Removal of School Transport – Faith Schools. In particular:

1. A copy of the letter previously sent by the local authority to Edwina Hart, dated 21 November 2014.
2. Copies of any letters or correspondence that were sent to Swansea County Council relating to the Judicial Review by either: Edwina Hart, the Legal Department or the Counsel General.
3. Copies of any letters sent by Swansea County Council to: Edwina Hart, the Legal Department or the Counsel General relating to the Judicial Review – Removal of School Transport – Faith Schools.

I can confirm that we hold information relating to your request and have enclosed correspondence that is captured (Docs 1– 3). Please note that names have been redacted under Section 40(2), Third party personal data of the Freedom of Information Act (FOIA) 2000. The reason for applying this exemption is set out at Annex A.

Annex A

Section 40(2) – Personal Data

Section 40(2) of FOIA requires third party personal data to be withheld in circumstances where its disclosure would breach any of the data protection principles set out in Schedule 1 of the Data Protection Act 1998 (DPA)

We consider that disclosure of this personal data would breach the first data protection principle. The first data protection principle requires that processing of personal data must be fair and lawful, in particular, that it should not be processed unless one of the conditions set out in Schedule 2 of the DPA is met.

In determining whether disclosure would contravene the first data protection principle, we have considered whether disclosure would amount to fair and lawful processing of those individuals' personal data. The individuals concerned do not have public facing roles. We consider that those individuals would be under reasonable expectation that their information would remain confidential and not disclosed to the public at large.

As such, we do not consider that disclosure of the withheld personal data would be fair. Guidance from the information Commissioner's Office (Personal information (Section 40 and regulation 13) v1.0 states:

"The public authority must decide whether it would be fair to disclose the personal data. If the public authority concludes that it would not be fair, then it must not disclose the information in response to the FOIA request"

In this instance, because the individuals would have had no expectation that their personal data would be released into the public domain, we believe that release of this information would be unfair and so breach the first data protection principle. For that reason, the information is being withheld under Section 40(2) of the Freedom of Information Act. This is an absolute exemption and not subject to public tests.
