## Request for Information – ATISN 10504

I wrote to you on 15 June regarding your request for information. You asked for information on the Brynglas Tunnel lighting. In particular:

- 1. Has a contract been awarded to replace the temporary lighting in the Brynglas Tunnel (following the fire in July 2011)?
- 2. What is the anticipated date of completion of the remedial work?
- 3. What is the anticipated date for the removal of the temporary speed restriction?
- 4. If no contract has been awarded, why not?

I can confirm that work is scheduled to commence on the refurbishment of The Brynglas Tunnels from the 20<sup>th</sup> June 2016, and that a statement in relation to this was made on the 9<sup>th</sup> June 2016. Please see link -

In response to your specific queries: A contract has been awarded for the refurbishment of the whole tunnel. Refurbishment works are scheduled to be completed by February 2018, the West bound bore being refurbished first, followed by the East bound bore. Removal of the temporary speed restriction on the West bound bore is anticipated by April 2017.
