Dear Anna,

Thank you for your email confirming that the Council intends to proceed with works for the removal of asbestos from within Grove Park School, Wrexham.

It is a matter for the Council to decide whether to proceed with the proposed work and we have no remit. Generally, however, you will be aware that it would normally be considered to be premature to start any work that could have the effect of changing the historic character of a building while it is under consideration for listing. In terms of the current position, on 12 April we received some new information from the person who made the request for the building to be listed. This new information will now need to be taken into account and considered as part of the peer review that is being undertaken by Historic England. As the additional information has only recently been received, the peer review will take a little longer to complete. The aim is to complete the peer review by the end of April and it will then need to be taken into consideration in deciding whether the building meets the criteria to be listed.
