**Request for Information – ATISN 10572**

Thank you for your request for information which I received on 10 July. In your request you asked for a copy of the T1 contractual document. In particular: the part which specifies Carmarthenshire Council is responsible for the T1 timetable between Aberystwyth and Carmarthen and also that the T1 must arrive at 20:37hrs at Carmarthen rail station allowing 10 minutes before the next train. You also asked for the name, job title and contact details of the person at Carmarthenshire Council who is responsible for the departure times in Aberystwyth.
