Complaint in respect of Request for Information – reference ATISN 10500

I wrote to you on 14 July regarding your request for an internal review. I have conducted an internal review in accordance with the procedure outlined in the <u>Welsh Government's Practical Guide for Making Requests for Information</u> which is available by post on request, or via the internet.

I note in your original request you asked for details of the financial package given by the Welsh Government to Aston Martin to locate a factory in Wales. In our response dated 7 July, we replied that to date Aston Martin has not received any grants or financial support from Welsh Government. In your email complaint of 11 July you expressed surprise at the reply you received and that you were aware of a financial package agreed with Aston Martin.

I have reviewed your request and have concluded that the original response provided was indeed correct. You asked for details of the financial package given and we replied that to date Aston Martin had not received any grants or financial support from Welsh Government. It is my view that the specific question asked has been answered, the complaint is therefore not upheld.

A financial package has been agreed with Aston Martin to locate a factory in Wales, but as you are aware, this information has been considered exempt from disclosure under section 43
