Request for Information – reference ATISN 10631

Thank you for your email of 22 August providing clarification of your request. Your request is divided into three distinct areas. The Welsh Government holds some of the information covered by your requests and I have addressed each below.

Firstly, you asked for Information supplied and reviewed by the Welsh Government and all its agents, leading to the appointment of Trevor Purt as head of Betsi Cadwaladr University Health Board. The Welsh Government does not hold any information meeting the description of this part of the request. Health boards are independently constituted organisations rather than agents of the Welsh Government, and any requests for information they may hold would need to be directed to them directly.

Secondly, you asked for the reason why Mr Purt was suspended and subsequently dismissed following his promotion to resolve issues around the mental health ward at Betsi Cadwaladr Health Board. Mr Purt was suspended by Betsi Cadwaladr University Health Board following the announcement by the (then) Minister for Health & Social Services of the decision to put the health board into special measures. As Mr Purt was not dismissed by the health board, the Welsh Government does not hold information in respect of this part of your request.

Finally, you asked for the reason why Betsi Cadwaladr Health Board was put in special measures. The information relating to this part of your request is contained in the links below:
