Thank you for your request which was received by the Welsh Government on 23 August 2016. You asked for the following information:

With reference to the Welsh Government's 'redeployment pool' (i.e staff on permanent contracts, not permanently assigned to any specific department):

- How many members of staff were in this category as of a) 31<sup>st</sup> March 2015, b) 31<sup>st</sup> March 2016 and c) latest figure available?
- How many staff in the redeployment pool are assigned to each government department?
- What is the currently the longest period of classification for any individual currently in the pool?

## **ANNEX 1**

The Welsh Government's 'Solutions' initiative facilitates the redeployment of staff between Welsh Government Departments. When an individual is registered with Solutions, they are assigned to a Department on a temporary basis to undertake work assignments prior to being matched to a permanent post.

This approach has simplified the redeployment process following business restructuring and has allowed us to fill posts vacated by staff leaving the organisation quickly and effectively. The availability of staff to undertake short-term projects and assignments also negates the need to employ temporary or agency staff to undertake these roles. The longest period for any individual currently registered with Solutions is 16 months.
