Request for Information – ATISN 10677

I wrote to you on 22 August regarding your request for information. In your request you asked:

- 1. How many road traffic collisions have occurred on the Skewfields Roundabout / A4042 Junction, Pontypool between the period 19th May 2010 and 19th May 2016?
- 2. How many of those collisions involved push bikes and/or motorcyclists?
- 3. Have there been any serious injuries or fatalities as a result of these collisions?
- 4. Has the road layout and/or the road markings changed between the period 19th May 2010 and 19th May 2016?
- 5. If so, what changes were made and why was the decision taken to make the changes?
- 6. Have there been any complaints or petitions about the lack of road markings and/or the road layout between the period 19th May 2010 and 19th May 2016?
- 7. It appears that the road markings on the Skewfields Roundabout / A4042 Junction, Pontypool do not comply with the Highway Code. Were any reports and/or traffic surveys undertaken before countermanding the Highway Code? If so please provide a copy.
- 8. Is there an internal policy on this to justify departing from normal procedure? If so please provide a copy.

I confirm that we hold some information relating to your request. Data relating to Q1, 2 and 3 of your request is attached at Annex A.

I can confirm that the roundabout had new signs and road markings constructed and works undertaken to help reduce the vehicle conflicts/incidents. These works commenced on 30 April 2013 and completed on the 10 May 2013. Since their completion only slight injury collisions have been recorded. This work included:-

- A new chevron board on the roundabout opposite the A472 arm from Pontypool.
- New passively safe screen deflection posts in the visibility splay on the A4042 SB carriageway from Abergavenny.
- New road markings on the roundabout and the A472 SB, A4042 SB and NB.

There have been no official complaints received by the Welsh Government regarding this roundabout. However, we have received correspondence between 2010 and 2013 from members of the public regarding concerns with the roundabout. All petitions received are available on the National Assembly for Wales website:

http://www.assembly.wales/en/gethome/e-petitions/Pages/e-petitions.aspx. There are no current petitions on this subject.

The Highway Code is the official guide for all road users including drivers, motorcyclists, cyclists, horse riders and pedestrians to using the roads safely and legally. It is not a design guide for highway engineers. The Traffic Signs Regulations and General Directions 2016, SI 2016/362 (TSRGD) prescribe the form and character of road signs and markings that may be placed on roads in Great Britain. Further guidance on the application and use of signs and road markings may be found in the Traffic Signs Manual (TSM). Chapter 5 of the TSM is specific to road markings.

Road markings may be used to channelise traffic and indicate which lane to use at and through roundabouts. Further details may be found in Advice Note TA 78 / 97 in the Design Manual for Roads and Bridges, Volume 6. In this respect, the road markings do not countermand the Highway Code.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
