ATISN 10739: information on Special Education Needs (SEN) pupils Key Stage 2 assessments for Llangennech Junior school, Carmarthenshire.

Thank you for your request to the Welsh Government for information under the Freedom of Information Act 2000, received on 6 September.

You asked for information on the SEN pupils in either streams (Welsh M or English M) information for the Llangennech school.

We sought clarification about your request on the 12 and 21 September, and as we received no further clarification, we have interpreted the request as being for:

- **the last 5 years of Key stage 2 assessments taken all together:**

For Llangennech Junior school - Looking at only those pupils who are SEN and not eligible for free school meals:

**How many pupils in that 5 years were assessed in Welsh first language?
How many of those do you have home language information for (speaks Welsh at Home/does not speak Welsh at home)?
For those who speak Welsh at home and those who do not speak Welsh at home separately:-
What percentage attained below level 4 in each of the core subjects?
What percentage attained level 5 (including above level 5)?**

The information you requested is enclosed in Annex 1.

(b) 'Speaking Welsh at home' mainly represents parents perceptions of their children's fluency and will not necessarily be the same as the ability shown by the pupil in their school work.

(c) 'Lower than level 4' includes National Curriculum Levels 1, 2, and 3, National Curriculum Outcomes 1, 2 and 3, disappplied pupils and pupils not awarded a level for reasons other than disapplication.

(d) Please note that the results for English, Mathematics and Science include only those pupils who were also assessed in the 'Welsh first language' subject.

(e) 'Level 5 or above' includes National Curriculum Levels 5, 6, 7 and 8, and exceptional performance.

(f) SEN provision includes School Action or Early Years Action, School Action Plus or Early Years Action Plus and Statemented pupils.
