A farmer nearing the end of a Farm Business Tenancy is refusing to provide sight of any documentation concerning his farming activity on land in this Authority's ownership. [TB testing/IACS claims/Milk Quota movements/Livestock Movements etc.] We also have concerns that he has failed to remove plastic silage wrapping and other debris from another agricultural property which he has refused to vacate in defiance to a County Court Order for Possession deadline.
