Many thanks for sharing these documents with us. Please find attached the message we plan to issue to staff tomorrow. Though based on the draft sent to us, it has been adapted to reflect our current position on this significant matter.

As both Elisabeth and I stated at the Steering Group meeting, we are committed to contributing fully to the discussions and are keen to explore options for greater collaboration between Wales' heritage organisations, whilst respecting our individual identity, independence, integrity and core purpose. We are attending the Steering Group without prejudice and need to consider following publication the implications for Amgueddfa Cymru as the proposals develop. Our Board of Trustees meets on Thursday and will discuss the Museum's response to the statement. We would ask that all communication and messaging reflects our position.

Catrin has requested sight on the statement and press release, and we would also like to request a copy of the proposed stakeholder communication. We would be grateful of confirmation that the content of each of these documents will not differ in any significant way from the most recently updated Terms of Reference. I would be grateful if you could also confirm that the PwC report being published tomorrow is unchanged from the version we received in July.
