Total Programme 100.5 million Local Authority £51.8 million Welsh Government £48.7 million (plus £2.2 million)

2. Full Project

Total Programme £120.5 million Local Authority £61.8 million (plus £10 million) Welsh Government £58.7 million (plus £12.2 million)
