Contract information relating to following:

Standard Firewall (Network) - Firewall service protects your corporate Network from unauthorised access and other Internet security threats

Intrusion Detection - <u>network intrusion detections systems</u> (IDS) and <u>network intrusion prevention systems (IPS)</u> services that detect Web application attacks and include anomaly-awareness in addition to handling older threats that haven't disappeared.

Web Applications Firewall - A Web application firewall (WAF) is a firewall that monitors, filters or blocks the HTTP traffic to and from a Web application.

Threat Monitoring - organizations and security analysts to identify and protect against security threats.

Anti-virus Software Application - Anti-virus software is a program or set of programs that are designed to prevent, search for, detect, and remove software viruses, and other malicious software like worms, trojans, adware, and more.

Encryption Facilities - s a host based software solution designed to encrypt sensitive data before transferring it to tape for archival purposes or business partner exchange.

- 1. Who is the existing supplier for this contract?
- 2. What does the organisation spend for each of contract?
- 3. What is the description of the services provided for each contract?
- 4. What is the expiry date of each contract?
- 5. What is the start date of each contract?
- 6. What is the contract duration of contract?
- 7. What is the hardware brand? If available.
- 8. What is the software brand? If available?
- 9. The responsible contract officer? Full name, job title, contact number and direct email address.

The Welsh Government's deployment and use of cyber security tools and services forms part of an overall ICT outsource arrangement with these services provided by our contracted ICT outsource supplier. We do not hold individual contracts for the cyber security services listed in your request. As such individual contract and service information for contracts does not exist. I am able to provide an overall description of the contract arrangements in place with our ICT outsource provider.

In 2004, the Welsh Government awarded a contract to Siemens Business Services (which was novated to Atos ICT Services and Solutions Ltd in 2012) to provide a fully managed service for ICT systems and services for a period of 10 years (2004 to 2014). In 2012 a decision was taken to extend the contract by a further 5 years to Jan 2019 (15 years in total). The contract is known as the Merlin contract.

As part of the Merlin contract Atos provide the management, maintenance and compliance of security management for Welsh Government. This includes the following elements:

- InfoSec Policy Maintenance
- Information Security Risk Management
- Management and Assurance of Compliance with Customer Policy
- Risk Register/Dispensations Log
- Enterprise Security Architecture Design
- Security Change Management Review
- Legal Compliance Implications for Information Security
- Security Incident Management
- Patch Management
- Secure laptop, desktop, server and client builds
- Access control permissions and user accounts
- Effective Vulnerability and Penetration Testing Management
- Protective Monitoring and Exception analysis
- Secure Backup and Recovery
- Secure Disposal
- Security Audit and Review Programme
- Security Governance (ISMF)
- Security Issue Management

These services are covered within an overall service management charge for which we do not hold individual contract information or costs for these security services. Alongside the services listed above the following annual service costs are identifiable:

- Firewall Services £120,859.
- Protective Monitoring £137,448

To support the above services a range of hardware and software has been procured. The table below lists the existing annual operational costs (2016/17) for hardware and software.
