## ATISN 10919 - Locality Teams

Thank you for your request to the Welsh Government for information under the Freedom of Information Act 2000, received on 14<sup>th</sup> November.

You asked for information on how many locality teams exist across each Health Board and for each of those teams,

- 1) how many have an established sustainability team
- 2) how long has the locality team been in place
- 3) how many members of staff are on the locality team
- 4) what are the job roles of each member of staff on the locality team

I sent you a request for clarification on 28 November. You clarified as follows:

'I apologise if I wasn't clear but I was indeed referring to primary care teams within the Health Boards. What I wanted to know was how many of those primary care teams have had a sustainability team in place, how many members in those sustainability teams and what are their roles as well as if possible how they are funded.'

Welsh Government does not hold this information.

Health boards are best placed to advise on the construct of their primary care teams, the key roles, and funding. In this context, you may wish to consider contacting Health Boards directly.
