Answer Our previous disclosure to you reference ATISN 10775 referred to the current approved business plan. A revised ICT Business Plan is currently being drafted and is expected to be completed by April 2017

Question ICT Technical Strategy

Answer An ICT Technical Strategy document is currently being drafted as part of the revised ICT Strategy and is expected to be published by June 2017.
