For every local health board and NHS Trust in Wales could you please provide:

- 1) name of board or trust
- 2) name of its chief executive as of today's date
- 3) names of all referees given by the chief executive in his or her application for the post
- 4) for each referee
 - (a) the name of their employer or employers as stated in the application
 - (b) information as to whether or not each employer was a commercial supplier of goods or services to any part of the NHS at that time and if so,
 - (i) the total value of its contracts with the NHS
 - (ii) what those contracts were for,
 - (iii) information as to whether or not it had any contracts with that particular LHB or Trust and
 - (iv) if so, their total value and what they were for

Questions 1 and 2 – this information is exempt from disclosure by virtue of s21(1) of the Freedom of Information Act. The information requested is in the public domain. The *Health in Wales* website provides links to all health bodies in Wales from which you can identify the individual CEOs.
