ATISN 11210 – Request for Information

Thank you for your request received via RPW Online on 20 March 2017. You asked for information about Good Agricultural and Environmental Condition in Wales and in particular:

i) whether farmers in your jurisdiction have been subject to sanctions other than the sanctions or penalties provided for in the basic EU Regulations and in particular whether farmers have been subject to criminal sanctions or fraud prosecutions under national law?

ii) to what extent have the maximum penalties under the basic EU Regulation been applied? Would it be possible to have a breakdown of the application of sanctions and penalties?

Our responses apply to the schemes in Wales.

- i. Where a legislative standard is also a Cross-Compliance verifiable standard, and if the non compliance identified warrants it, we, or other enforcement bodies, will prosecute the offender under domestic legislation as well as applying the appropriate Cross-Compliance penalty
