ATISN 11219 - St David's Foundation Hospice In-Patient Unit, Newport

Thank you for your request to the Welsh Government for information under the Freedom of Information Act 2000, received on 30 March.

You asked for information in relation to the in-patient unit currently being built by St David's Foundation in Newport, specifically:

- 1. How much public money has been granted towards the cost of the unit?
- 2. Was this capital funding or revenue funding?
- 3. What due diligence was carried out to establish the sustainability of the unit?
- 4. If capital funding was provided, how was on-going revenue funding investigated to ensure the project is sustainable?
- 5. Has any other public funding been allocated to this project e.g. Health Board Funding?
- 6. How has the Welsh Government established that this is an appropriate model for the provision of in-patient specialist palliative care, and how has it ensured it meets the needs of all residents living in the five boroughs of Gwent.

Annex A

1. How much public money has been granted towards the cost of the unit?

In April 2015, St David's Hospice Care (SDHC) were awarded £3 million over two financial years – 2015-16 and 2016-17.

2. Was this capital funding or revenue funding?

The funding was all capital funding and I enclose a copy of the funding approval letter.



3. What due diligence was carried out to establish the sustainability of the unit?

The Health and Social Services Finance Division undertook a Due Diligence Review in June 2015, a copy of the review is enclosed.



A letter of support was also received from Aneurin Bevan University Health Board in November 2014 confirming the health board looked forward to working with SDHC and fully supported the development; a copy of the letter is enclosed.



The business case was also reviewed by the Health and Social Services Infrastructure Investment Board (IIB) in March 2015 where SDHC provided a presentation on the project and IIB subsequently agreed that the project should receive Welsh Government support. A copy of the SDHC Business Case is enclosed.



4. If capital funding was provided, how was on-going revenue funding investigated to ensure the project is sustainable?

Sustainability of the project was considered as part of the scrutiny of the SDHC Business Case.

5. Has any other public funding been allocated to this project e.g. Health Board Funding?

No further Welsh Government funding was allocated to the project.

6. How has the Welsh Government established that this is an appropriate model for the provision of in-patient specialist palliative care, and how has it ensured it meets the needs of all residents living in the five boroughs of Gwent.

The SDHC Business Case was reviewed by Welsh Government officials who oversee Health Care Policy including Palliative Care across Wales and it was considered that the proposals met the end of life care needs for South East Wales. This is supported by Aneurin Bevan University Health Board's end of life care strategy 2013- 2016.
