A496 Llanbedr Access Improvement scheme

- Draft Written Scheme of Investigation for Archaeological Mitigation;
- Summary of access improvement mitigation for the scheduled monument known as ME056 Llanbedr Standing Stone;
- Draft Archaeological Evaluation Trenching Report; and
- ASIDOHL

Please accept my apologies for the delay in responding to your emails.

The proposed Access Improvement Scheme will have an impact on the setting of the scheduled monument ME056 Llanbedr Standing Stone; potential ways to mitigate this impact were discussed at a site meeting last year, including additional tree planting, along with improved access and interpretation to the site from the village. We consider that the concerns raised by on this matter have been taken into account by the developers, and as such we are content with their proposals. We would however wish to be consulted about the content and location of the proposed interpretation panel for the scheduled monument, and also the location of any associated development such as waymarkers or footpath furniture.

Turning to the ASIDOHL assessment, we concur with the assessment's conclusion that the proposed scheme will have a fairly severe impact on the Historic Character Areas 14 and 15. This will therefore constitute a significant impact to be considered in the EIA and when any application for the scheme is determined.
