Thank you for your email of 9 May asking for the following information under the Freedom of Information Act 2000:

ALL DATA REQUESTED BELOW IS ONLY FOR <u>NOT ELIGIBLE FOR FREE SCHOOL</u> MEALS FOR BOTH GCSE WELSH 1 AND GCSE ENGLISH.

Looking only at Welsh medium (including bilingual schools)
How many pupils were entered for GCSE Welsh first language (either Lang or Lit)?

Of those pupils how many "Speak Welsh at home"? How many "Do not speak Welsh at home"?

Of each group how many were not eligible for free school meals?

Looking at the two groups:

What percentage of the A*and A grade (taken together; ie the two groups of "A" pupils together = 100%) was achieved by:Pupils who spoke Welsh at home?
Pupils who did not speak Welsh at home?
