Re: ATISN 11316 - NHS and social care staffing

Thank you for your email of 27 May 2017 asking for information under the Freedom of Information Act (2000).

The Welsh Government holds some, but not all of the information you requested.

- a) Numerically and as a percentage of total staff numbers, how many staff working in the Welsh NHS, who could be classed as immigrants:
- 1. Have a UK passport
- 2. Have an EU passport
- 3. Have a non EU passport

The Welsh Government does not hold passport data, but the following information may be useful for (a):

The Welsh Government Knowledge and Analytical Service has recently made two ad hoc publications showing doctors in Wales by country of first qualification and Nursing and Midwifery Council registered staff working in NHS Wales by country of first qualification. This information is not available for other staff groups working in NHS Wales.
