FREEDOM OF INFORMATION REQUEST - ATISN 11337- LIST OF BUILDINGS IN DENBIGHSHIRE REJECTED FOR LISTING

Thank you for your request which I received on 13 June. You asked for a list of buildings in Denbighshire which were considered for listing in 2005 but were rejected, and for each property the reasons why it was not listed.

Following a search of our paper and electronic records, I have established that the information that you have requested is not held by the Welsh Government. If you are concerned about a particular building, or buildings, I would be happy to discuss your request in more detail and I can be contacted on the above telephone number.

By way of background it may be helpful if I explain that there is a statutory duty on the Welsh Ministers to produce a list of buildings of special architectural or historic interest and this list is available online at:

In 2005, we completed a national survey of buildings in Wales which involved us producing lists of buildings within each community that were judged to be of special architectural or historic interest. However, we did not record information about every building that was assessed and subsequently rejected.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.
