## Request for Information – ATISN 11335

I wrote to you on 16 June regarding your request for information. In your request you asked for:

- 1. Traffic volume, improvement and capacity reports for J32 of the M4 at Coryton interchange from 15 December 2014 to 8 June 2017.
- Welsh Government correspondence with Velindre Cancer Centre in relation to traffic regarding its proposed new centre off Longwood Drive and the potential impact on traffic at this junction and the surrounding area from 15 December 2014 to 8 June 2017.

In response to the first part of your request, the Welsh Government have not commissioned any operational studies, reviews or assessments since the last improvement scheme (link road between the westbound off-slip and the A470 northbound carriageway) in September 2014. As this information is otherwise available, this part of your request is considered exempt under Section 21 of the Freedom of Information Act 2000, information reasonably accessible by other means.

In response to the second part of your request, we do not hold any of this information. The Welsh Government has not been formally consulted on the planning application for the proposed new Velindre Cancer Centre off Longwood Drive so no considerations or decisions have been made regarding any potential impact on traffic at this junction and the surrounding area.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an
