ATISN 11351 Anti-depressant prescribing to under-18s

Thank you for your request to the Welsh Government for information under the Freedom of Information Act 2000, received on 20 June. You asked for information about:

- 1. Information from 2012 2017 about the number of patients in Wales who received antidepressant drug prescriptions for the age ranges below:
 - 13-18
 - 7-12
 - 6 or younger
 - Breakdown by health board (if available)

Welsh Government does not hold prescribing data by age. Data on characteristics of those issued prescriptions are held within GP systems.

The following information may be relevant to your request:

The Welsh Government commissioned research by Swansea University regarding trends in primary-care antidepressant prescribing to children and young people. This used data that were available through the Secure Anonymised Information Linkage Databank (SAIL, https://saildatabank.com/) held by Swansea University. The report is available from https://www.ncbi.nlm.nih.gov/pmc/articles/PMC5122314/
