Dear Rhodri,

Further to my brief telephone discussion with Jonathan this morning and my previous message for you, I'm afraid we unable to attend tomorrow's meeting regarding the above.

For information, please find attached two recent officer reports relating to this property – one for an approval and one refusal. Over the years we have agreed various works to this property to enable it to be brought back into use. The sole sticking point is the latest proposal to completely remove the first floor. We have approved a scheme to raise the ceiling to provide greater head height and lose

the current step down into the property, to make it more commercially attractive. However we have refused a proposal to remove the floor in its entirety. This was debated at length, and we encouraged Mr Sutton to put in two applications, one we can support and he can commence on, and one that we are unable to support and could be called to Committee and/or appealed. We are hoping Mr Sutton will appeal his refusal and test the decision there.

As such, there is little potentially to be gained from a site meeting, and I am mindful that we are in the middle of a formal complaint process with Mr Sutton. However, I am willing to attend a meeting if it assists you.

We have also previously discussed at length Mr Sutton's concerns regarding the list description and have provided advice, as requested, on how he can apply to seek delisting. I understand that you have tabled an amended list description which may have overcome those issues.

I trust this clarifies our position.
