When we met with the Ministers back in December we discussed our youth project, The Filter and how it was being independently evaluated by Cardiff University. Both Ministers were keen to see the results of this when it was ready. By April this evaluation will be ready to present.

In addition we will soon have a detailed report about Illegal Tobacco situation in Wales. this report will give the Minister a wide picture of the availability and use of illegal tobacco including public perceptions, levels of reporting and the enforcement problem profile.
