Steve,

Thank you for this. Can I confirm that the 46 crimes from the NRM outside of police forces were not crimed until highlighted through my request.

This will be indicative of the issue across the UK and will demonstrate the problem in the most stark terms that only 10 per cent of allegations were being subject to a crime report.

Thank you for being so thorough. This gives me a very clear steer on my next steps.

As discussed I am employing someone to look specifically at law enforcement issues.

The lack of recording shows the very basics are missed and opportunities are being lost.

But I am pleased it is being addressed in Wales and I do hope that arrests will follow as there is a 90 per cent increase in crimes - hence more intelligence, suspects and victims for police to debrief.

Hello Kevin

Further to our recent conversations:

Please see the NRM referrals from Wales for the Quarters 1 & 2 2015, as proved by the NCA UK Human Trafficking Centre.

From the 51 referrals 5 were from Welsh Police Forces representing 10% of the referrals.

The 5 Welsh Police Force referrals (2 Gwent Police and 3 South-Wales Police) were all crimed and subsequently investigated.

Quarter 1 2015

There were 20 referrals submitted from Wales, only from 2 Police forces – all Gwent Police.

As you are aware I requested the Single Points of Contact in each of the Forces to retrospectively crime the 46 NRM referrals made by Bawso, New Pathways, UKBF, UKVI and the Local Authority (Newport City Council) and this exercise is confirmed to have been carried out.

The pilot to be introduced (01/09 to 20/11/15) will bring about a process for criming all NRM referrals generated from Welsh First Responder organisations. Further to our conversation on Friday, I have included in the process the means to crime referrals emanating from outside of Wales and the UK. We will monitor the pilot and make any necessary improvements as we are striving for 100% reporting and I will forward you our agreed process this Friday when comments have been received.

Our process is interim and we are looking forward to the UK solution to the process you are currently working on. However, as supporting evidence, if it can be achieved in Wales then there is no reason why we cannot have a UK solution!

I take it you have already engaged with Steve Bond the Home Office National Crime Registrar (Steve.Bond2@homeoffice.gsi.gov.uk) who is supportive of our work.

Thanks for the details and the report you submitted.

As we discussed can I have the data from police forces in Wales as below and your work to make sure all cases in Wales are subject of a crime report is excellent but as I mentioned this needs to be a national response.

I have raised this as a national issue already an as in the example I gave on the phone where someone reports elsewhere, it will still mean that crimes committed in Wales can still missed or indeed this can happen anywhere in the UK. Therefore a national coordinated response is required.

That said you making sure Wales is operating correctly in the interim is excellent.

As I explained, I want this to be 100 per cent compliance and if a process is created that does not achieve that for the entire UK we are still letting victims down, not complying with European Conventions and criminals are operating with impunity.

Very keen to meet to discuss a number of issues and of course the training that I am sure we can achieve quite a great deal by coordinated together.
