The term 'ring of iron' was coined in the 19th century to describe the chain of castles built by Edward I after the first and the second Welsh wars of independence in the 13th century. These castles were used to cement Edward's successful campaigns and put an end to Welsh ambitions for independence from England once and for all. Flint was one of these castles. So in effect some people may see the 'ring of iron' as some sort of reinforcement or celebration of this. It's interesting to note that , who had no sight of the proposal until now, thought this - but this may be because working as a civil servant in Wales we become sensitive to the politics.

We might be able to challenge this with the inscriptions on the piece or by making it more Celtic in some way within the ring design itself - that would be something we would need to discuss with the artist through the design / consultation stages.
