Request for Information – reference ATISN 11671

Thank you for your request under the Freedom of Information Act 2000 (FOIA) which I received on 27 October.


You asked for the following information for the last three intake years:

- a) Total no of applicants for undergraduate medical places for the medical schools in Wales.
- b) Total no of applicants (or proportion of total for a) which came from schools/colleges in Wales.
- c) Total no of applicants for undergraduate medical places for the medical schools in Wales which were accepted for a place.
- d) Total no of applicants for undergraduate medical places for the medical schools in Wales which came from schools/colleges in Wales and which were accepted for a place.

The Welsh Government holds some of the information of this description and it is enclosed at Annex A of this letter.

Information on applications and acceptances to Welsh universities is already publicly available and is regarded as exempt from release under s21 of the Freedom of Information Act - Information reasonably accessible to the applicant by other means. This exemption is absolute and thus not subject to the public interest test.

Annex A

Freedom of information request

We do not hold a complete set of the data requested relating to the number of applications and acceptances for medicine at Cardiff and Swansea medical schools. However, we do hold some of the information requested, which has been provided to Welsh Government by staff at Cardiff and Swansea medical schools. This is as follows:

Cardiff Medical School

For the 2017/18 intake, the total number of applications to Cardiff Medical School was 2101, of which 288 were Welsh domiciled (213 were interviewed and 130 offered place). 74% Welsh applicants were interviewed, with 61% of those interviewed offered a place.

In 2016/17 10.8% of applicants were Welsh Domiciled; 14% of which were interviewed with 24% receiving an offer.

In 2015/16 14% of applicants were Welsh Domiciled; 18.4% of which were interviewed; with 20% receiving an offer. The acceptance rate was 71%.

Swansea Medical School

For the 2017/18 intake, the number of applications to Swansea Medical School was 781, of which 120 (15.4%) were Welsh domiciled. Of these 120 Welsh domiciled applicants 47 (16.8% of total number) were offered an interview.

In 2015/16 17% of applicants were Welsh Domiciled; 17% interviewed; with 17% receiving an offer.

In terms of the information provided about Welsh domiciled enrolments / applications, the information provided is based upon individuals living in Wales at the time of application, we do not hold information about whether these individuals attended Welsh schools or colleges.

The medical schools have also provided the following information on first year enrolments for 2015-16 and 2016-17:
