I interpreted your request as asking for a list of Welsh Ministers' decisions on called-in planning applications or recovered appeals for residential development within Caerphilly County Borough Council between 20 November 2012 until 20 November 2017, which were determined by the Cabinet Secretary for Energy, Planning and Rural Affairs, formerly the Cabinet Secretary for Environment and Rural Affairs or her predecessors, between the aforementioned dates, following the refusal of planning permission by Caerphilly County Borough Council.
