ATISN 11759 Education budget

Thank you for your request which I received on 23 November 2017. You asked for:

- The overall allocated budget figure for each of the three tiers referred to within Education in Wales: Our national mission from the Budget for overall expenditure on Education at all levels in Wales: and
- A breakdown for each component part within the three tiers.

From my preliminary assessment I estimate that it will cost more than the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to answer your request. The appropriate limit specified for central government is £600. This represents the estimated cost of it taking over 24 hours of time to determine whether we hold the information and to thereafter locate, retrieve and extract it.

In order to provide you with the information that you have requested would require that the Welsh Government seek and collate information not held centrally in a way which we believe would satisfy your request. Consequently, I have decided not to provide you with the information you have requested.

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain, including any dates or period of time or specific areas of interest relevant to the information required. If you do refine your request in this way, this will be treated as a new request.

To support you I enclose links to some published reference information which you may find useful.
