### **Request for Information – ATISN 11831**

Thank you for your further request for information in relation to homelessness prevention funding received on 10 December 2017.

You have asked for a list of all third sector organisations that have received funding from the Welsh Government, and the amounts they have been provided with, for activities to combat homelessness.

The attached table provides the information requested, broken down by the various funding streams that focus on or support the aim to tackle homelessness. These funding streams are:

- Homelessness Prevention
- Supporting People
- Independent Living
- Financial Inclusion / Advice Services

Since 2012, management and procurement of Supporting People services has been undertaken by the local authorities. The attachment contains details of funding awarded to third sector bodies prior to that transfer. We are aware that service provision may have changed since 2012. To get an up to date pattern of investment of Supporting People investment you should make enquiries to each local authority.

The statutory duty to prevent homelessness rests with the local authority who will receive funding from the Welsh Government via the Revenue Support Grant.
