#### 2.0 Introduction

#### 2.0.1 General

1 This Network Management Manual (NMM) is Part 2 of Welsh Government's Trunk Road Maintenance Manual (WGTRMM). It is the third of three documents which together comprise WGTRMM. It provides advice, guidance on good practice and further detail of service requirements for some aspects of service delivery described in Part 1 including the management and provision of the routine and adverse weather maintenance service on the trunk road network in Wales.

2 The NMM comprises three Sections:

- **2.0 Introduction** (this section)
- **2.1 Health and Safety Management** providing an understanding of the roles and responsibilities of WG and Service Providers and a summary of the key issues that they as duty holders must consider to comply with health and safety legislation.
- **2.2 Service Requirements and Guidance** containing guidance information (GI) to be read in conjunction with corresponding parts of WGTRMM that this section supports. It provides the following:

The performance requirements for routine and winter service activities on the trunk road network are identified in Part 1 WGTRMM, the Service Code. The Network Management Manual together with the Code provides advice and guidance to enable Service Providers to identify and deliver the performance required.

The Network Management Manual is predominantly guidance and advice, which is commended to users for consideration. It should be noted that requirements arising from Statutory or other prescribed service requirements will be mandatory on the part of the Service Provider unless otherwise agreed with WG.

It is intended to be a transparent document which gives clarity on the standards and levels of service to which the network is to be maintained
