Details in relation to why NHS Wales Informatics Service have dropped EMIS as a preferred provider. Media has just reported it as EMIS' unwillingness to meet a large number of criteria. I would like to know on a high-level what are these criteria, how critical they are to the GP services - considering EMIS has been a main provider for so long, presumably providing fine services, what could be the stumbling blocks so major that NHS Wales is willing to go through the costs and many issues of changing IT provider?
