The number of NHS registered patients and associated LSOA, broken down by sex for each GP practice in Wales.

All data regarding GP practice patient data held by the Welsh Government is published in or alongside the statistical first release 'GPs in Wales'.

The postcodes in the patient data spreadsheets could be used in conjunction with the postcode to LSOA lookup spreadsheet to produce a dataset at an LSOA level. It will be possible for you to link this data with LSOA codes to produce estimates by LSOA and analyse according to deprivation quintile.

Please note that the GP patients data is based on the area of registration and any analysis of LSOA population will be based on people who live in that area.
