Dear Mark,

As you know we are deeply concerned at the impacts of the ongoing fiscal policy of UK Government. For the last two years we have made our case, and the case for local government as a family, for some relief from the impacts of austerity in public finance.

We have enclosed a personal letter to you setting out our needs for 2018/19. It is a responsible act for us to share our position so openly given the risks we face. We encourage Welsh Government to work with us to find solutions. It is clear that if the financial position does not improve we, as the sixth largest council in Wales, face the reality of having an unsustainable financial position. Our most recent Cabinet report on our Medium Term Financial Strategy accompanies the letter.

We have also written to the respective Cabinet Secretary/Minister for Social Care and Education respectively, Rebecca Evans and Kirsty Williams, as both sets of key mandatory services are showing significant signs of stress locally. It is not always a popular argument but, nonetheless, we do have to again explain that our low funded position (per capita) is now having the effects we had forewarned.

We look forward to a discussion with you as the build up to the 2018/19 budget setting continues. We are keen to jointly lobby UK Government through every available route and would appreciate your advice on how we can best engage with you in this work at this critical time.
