Request for Information – ATISN 12147

I wrote to you on 16 March regarding your request for information. You asked for information regarding a housing development of 111 houses (due to be submitted for planning in March) which will impact on the A40 Trunk Road at Raglan, the junction of the unclassified local roads (Monmouth Road and the Road to Mitchel Troy - shown in image provided) grid reference 342111,208138 with the A40 and the A40/A449 interchange:

1. Confirmation that these junctions, which are in close proximity, would not conform with today's design standards.
2. Details of any traffic surveys or traffic models which have been carried out for the region of this junction along with traffic flow data for, at least, the last three years.
3. Details of Departures from Standard which have been applied to these junctions
4. The Personal Injury Accident history relating to these junctions.
5. Details of any plans or proposals to improve or upgrade these junctions.
6. Copies of correspondence with the developer Richborough Estates, Penny Jones or Monmouthshire County Council relating to developments on the local Monmouth Road which will feed traffic onto this junction.

I can confirm that we hold some information relating to your request and this has been enclosed.

1. We do not hold recorded information relating to this question therefore cannot confirm or otherwise.
2. We are not aware of any surveys or traffic models that have been conducted therefore do not hold information of this description. This information may be available on the Department for Transport website - <https://www.dft.gov.uk/traffic-counts/>.
3. We don't hold information of this description.
4. There has been only one recorded accident (serious or fatal) in the last three years.(please see attached report)
5. There are currently no plans to improve or upgrade these junctions.
6. We do not hold any correspondence as described above.
