Hi [hepgorwyd adran 40(2)]

[hepgorwyd adran 40(2)] wants to do a piece before next Tuesday on the standards and has asked for a comment on why they don't include GPs. Apparently the Welsh Language Commissioner has gone on record before saying they should be included.

Officials are happy to brief [hepgorwyd adran 40(2)] in further detail about the reasons for this on Monday so I'll ask if he can hold off for the time being. If he's insistent on running something beforehand are you happy with the following holding line?

A Welsh Government spokesperson said:

“The Regulations which specify Welsh Language Standards for local health boards, National Health Service Trusts in Wales, Community Health Councils and the Board of Community Health Councils in Wales will be laid before the National Assembly for Wales on 27th February. We will comment further on the Regulations once they are laid.”
