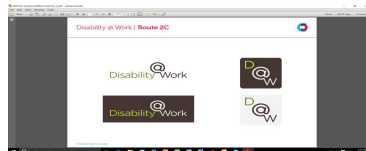

Disability

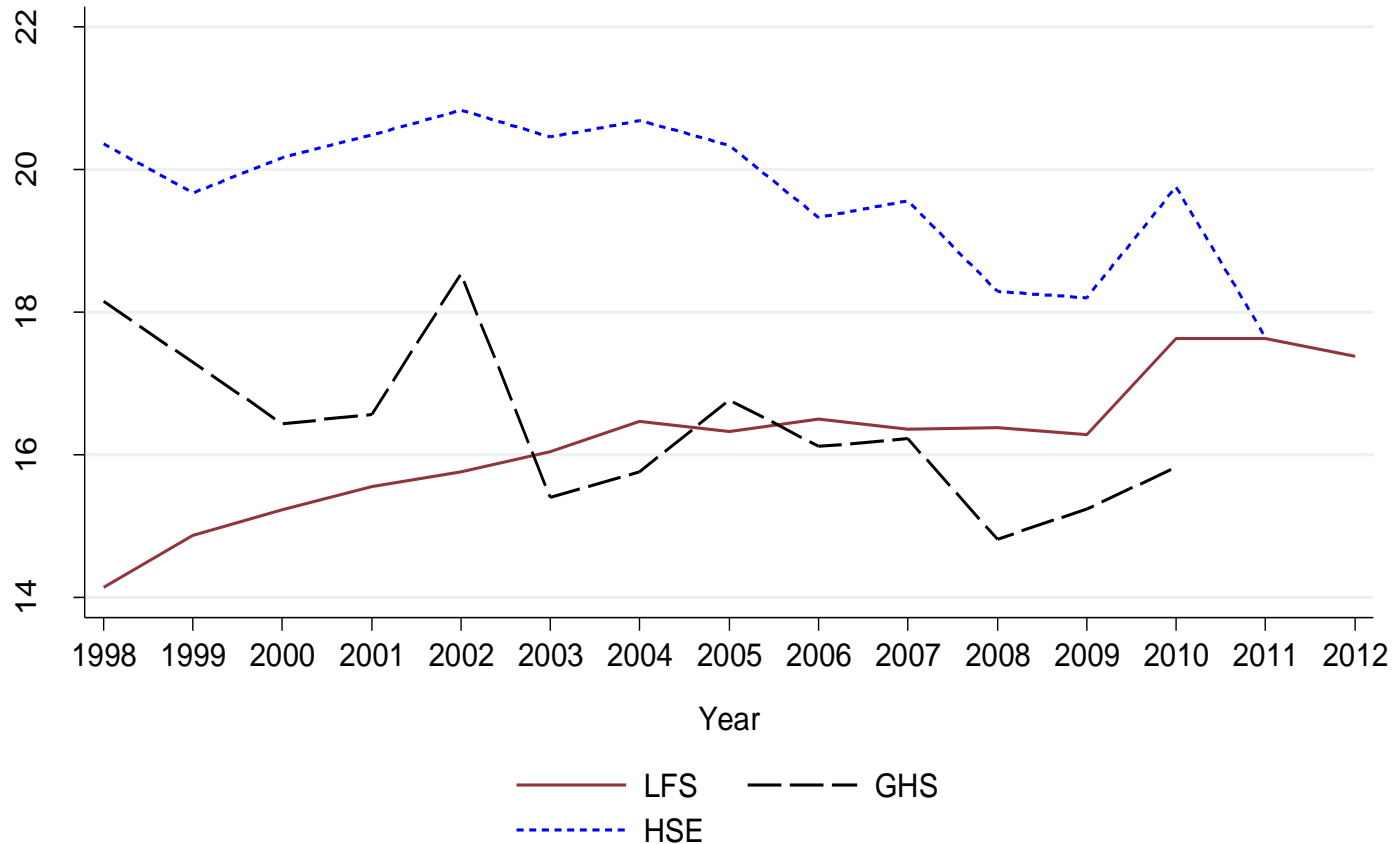
- Definition complex but important
- Self-assessed:
 - Disability Discrimination Act/Equality Act (daily activity)
 - Work-limiting (type or amount of work)
- Typical survey question:

Do you have any health problems or disabilities that you expect will last for more than a year? Yes/No

If Yes:

Do these health problems or disabilities, when taken singly or together, substantially limit your ability to carry out normal day to day activities? Yes/No

Disability-related Employment Gap

- Percentage point difference in the employment rate between non-disabled and disabled people of working age
- In 2012 the employment rate among disabled people was 46% and the equivalent figure for non-disabled people is 76%. The employment gap would therefore be 30 percentage points.
- Far larger than for other protected groups
- Key government disability equality indicator

Disability employment gap inquiry launched

30 March 2015

The Work and Pensions Committee launches an inquiry into the Government's commitment to 'close the 'disability employment gap' - the difference in employment rates between disabled and non-disabled people. The inquiry assesses the scale of the challenge and the likely effectiveness of the Government's employment support and benefit policies in achieving this goal.

Inquiry: Disability employment gap

Inquiry background
 The employment rate among disabled people stood at 46.7% at the end of 2013, compared with 80.2% for non-disabled people. To close the gap would require creating an extra 1.2 million disabled people in work.

Iain Duncan Smith criticises employers over disability employment gap

Experts welcome emphasis on improving support for jobs disabled people who want to work but say speech was light on detail

The government's aim to get one million more people with a disability or long-term illness into work will require changes to practice and attitudes on the part of job-seekers and employers, experts have said.

The work and pensions secretary, Iain Duncan Smith, said in a speech on Monday that he wanted to 'close the employment gap between disabled and non-disabled people by reforming the incapacity benefit assessment system and improving the levels of support for jobs disabled people who wanted to work.'

MPs voted against the Opposition Motion (Division No. 14 Aves: 215 votes, 166:109).

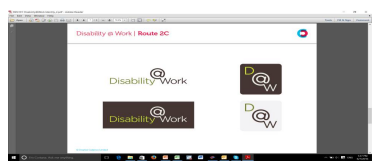
The Government amendment (A) was agreed without a Division.

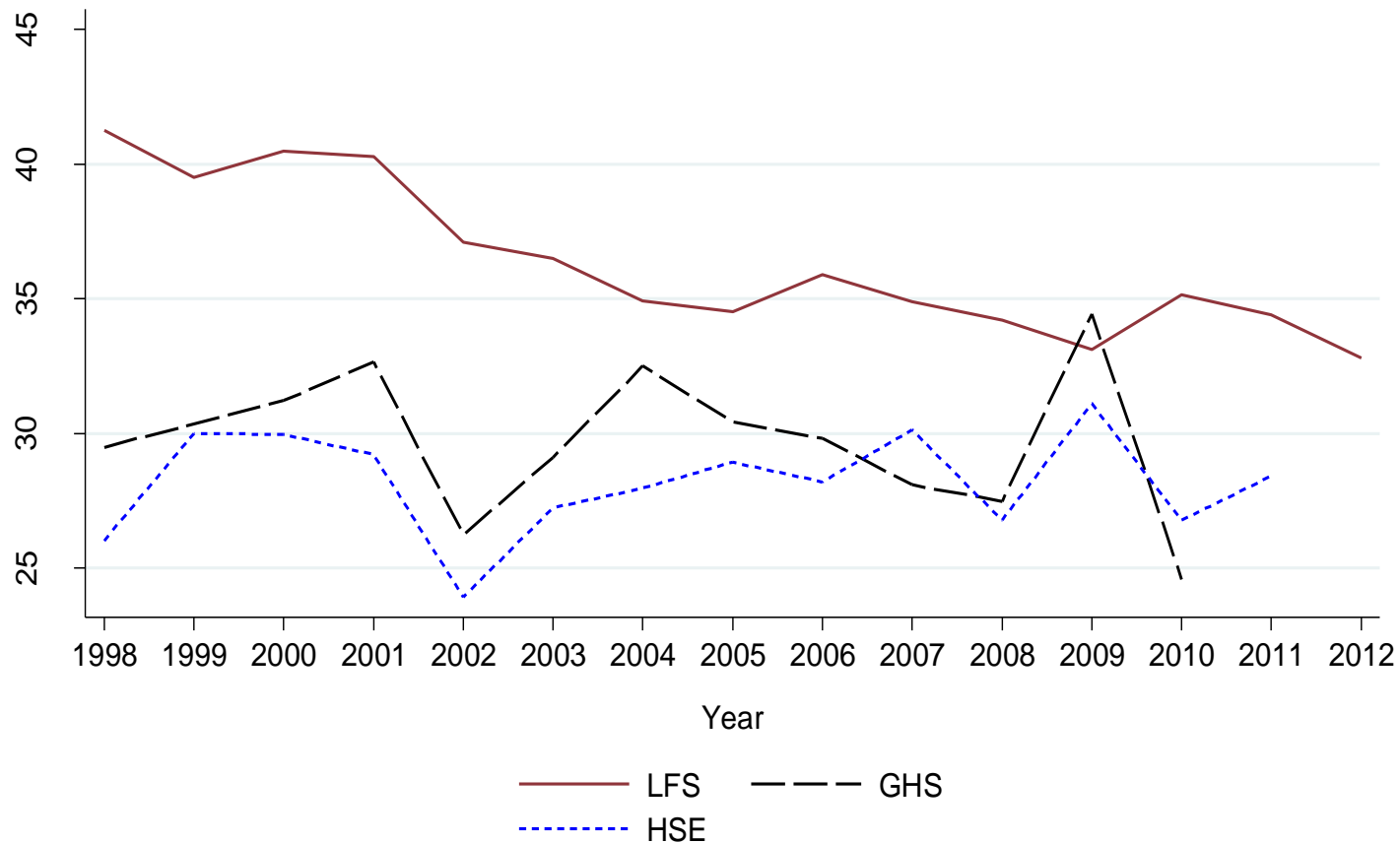
Disability employment gap

MPs voted against the Opposition Motion on the disability employment gap (Division No. 12 Aves: 223 votes, 166:109).

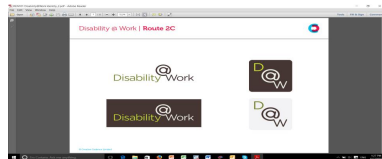

Disability-related Employment Gap

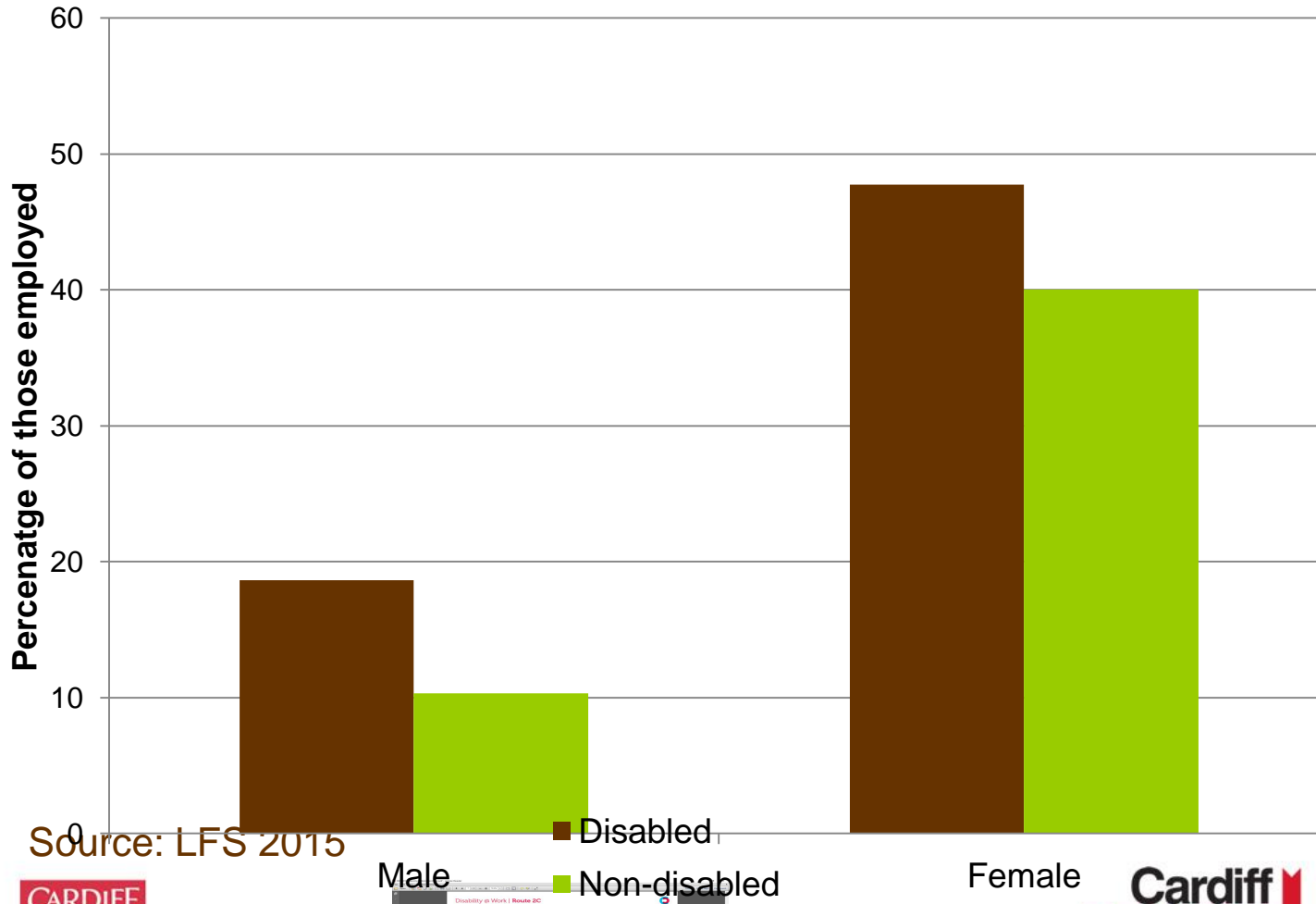

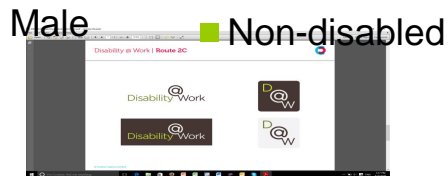


Does the type of work differ for disabled people?

Percentage of those in employment in part-time work

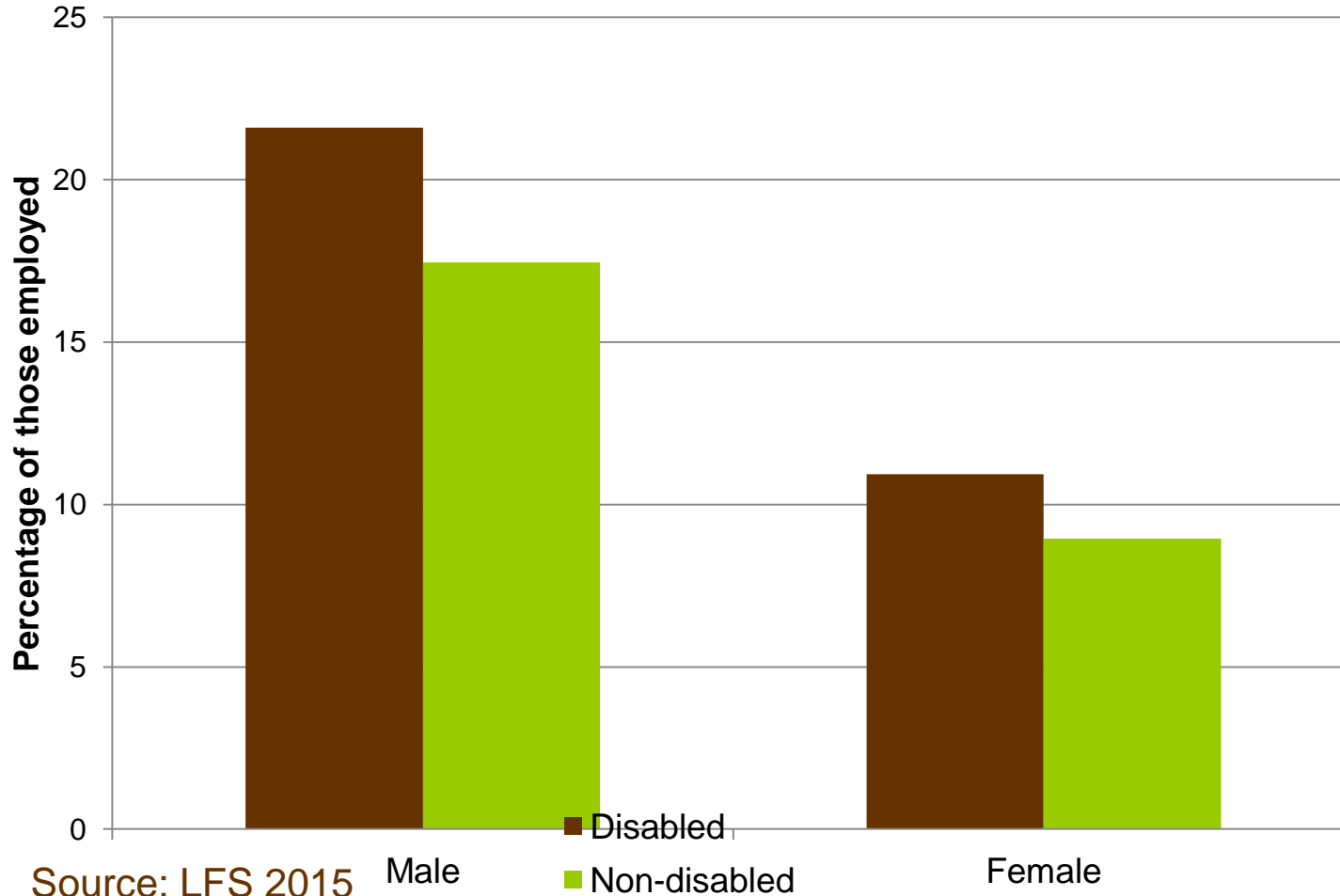

Percentage of those in employment in self-employment



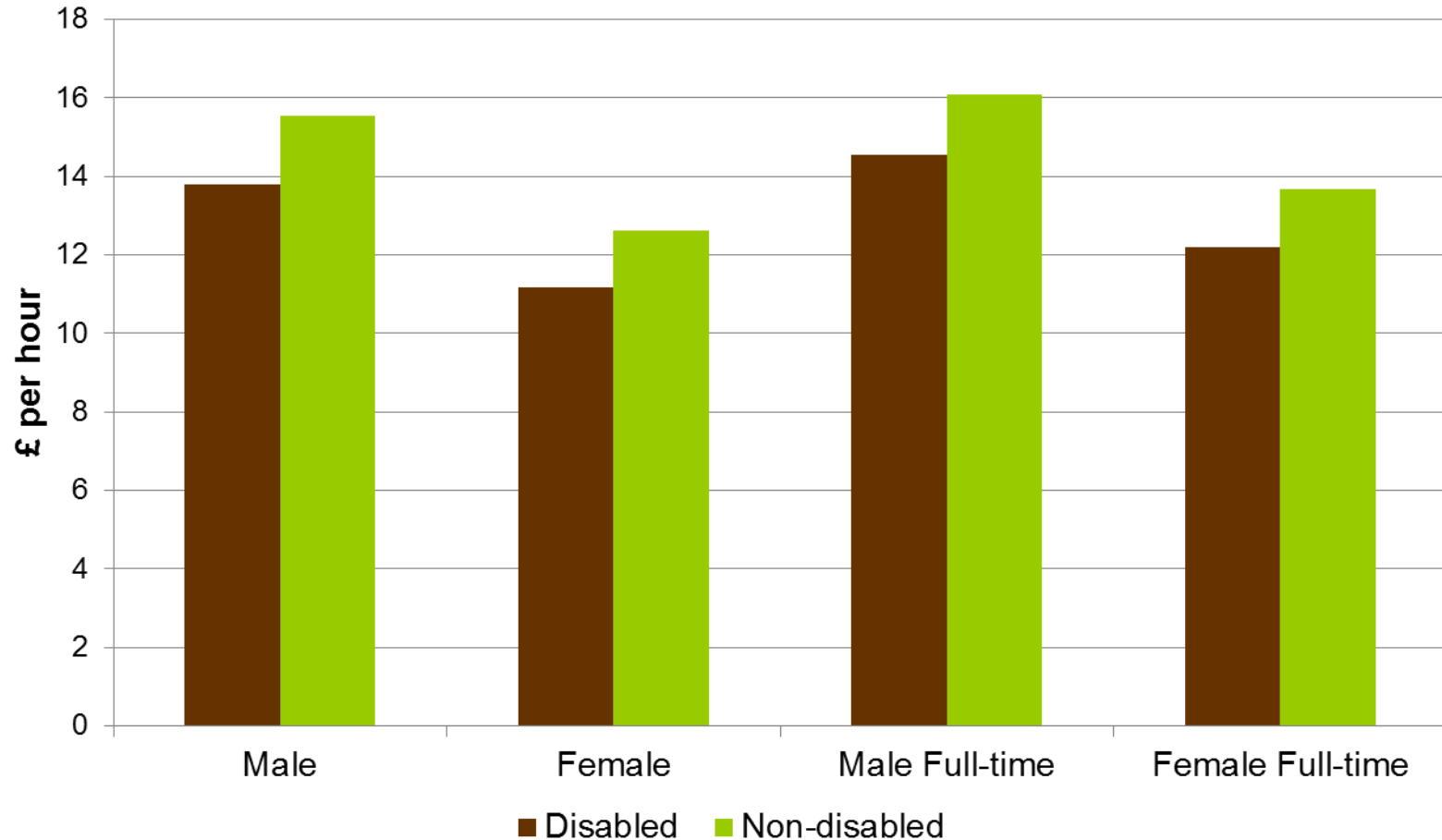

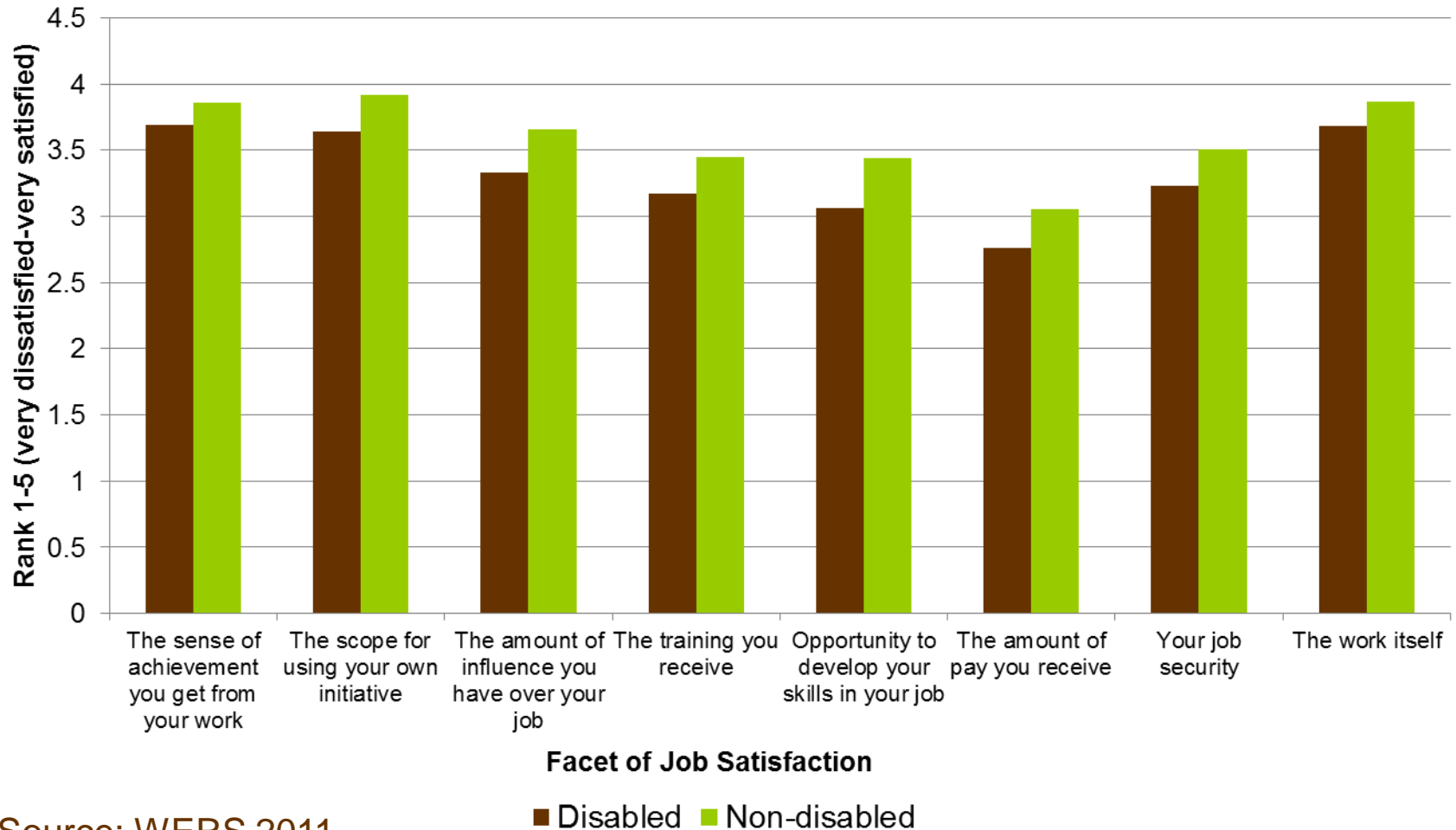

What about pay? The disability-related earnings gap

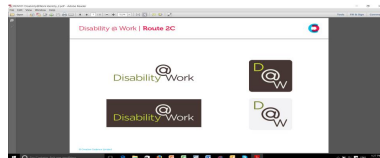

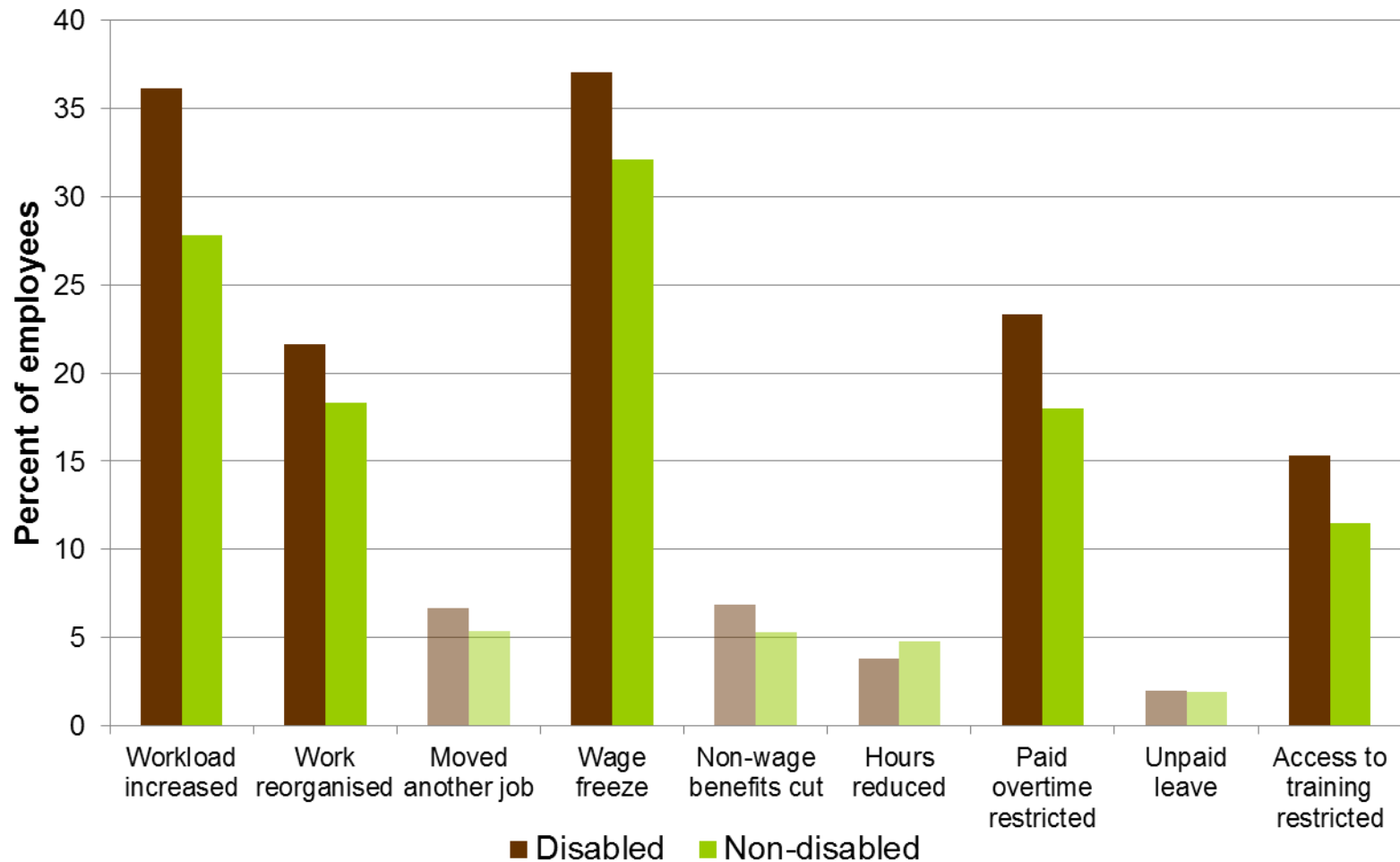
and well-being? Disability-related gaps in job satisfaction

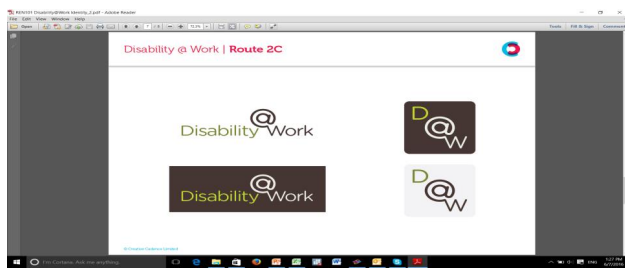

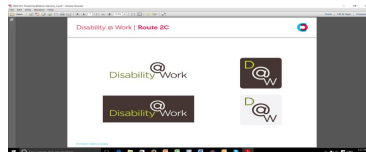

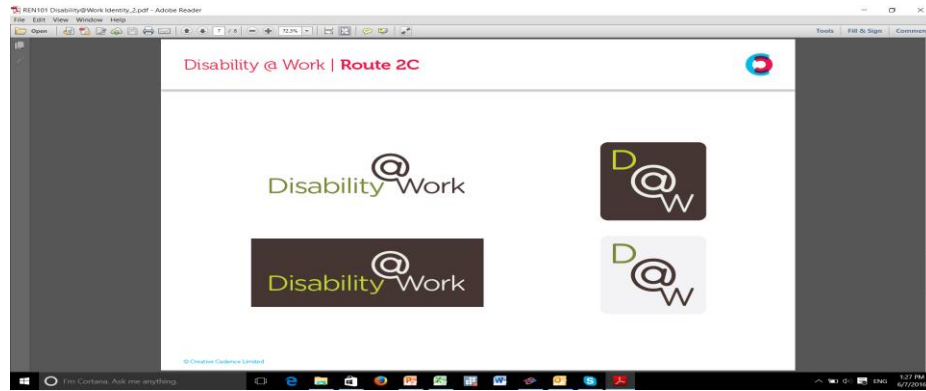
Research Programme
