Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer Cefnffordd yr A40 Rhaglan i Lanymddyfri, drwy arfer y pwerau a roddir iddynt gan adran 84(1)(a) a (2) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), ac ar ôl ymgynghori â Phrif Swyddog Heddlu Dyfed-Powys, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the A40 Raglan to Llandovery Trunk Road, in exercise of the powers conferred upon them by section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984(1) and after consultation with the Chief Officer of Dyfed-Powys Police, make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A40 (Llansbyddy, Powys) (Terfyn Cyflymder 50 mya) 2018 a daw i rym ar 21 Mai 2018.

1. The title of this Order is the A40 Trunk Road (Llanspyddid, Powys) (50 mph Speed Limit) Order 2018 and it comes into force on 21 May 2018.

2. In this Order:

ystyr "cerbyd esempt" ("*exempted vehicle*") yw:

"exempted vehicle" ("*cerbyd esempt*") means:

(a) unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(2);

(a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—

(i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu

(ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A40 Rhaglan i Lanymddyfri;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

3. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 50 milltir yr awr ar y darn o'r gefnffordd yn Llansbyddy, Powys sy'n ymestyn o bwynt 650 o fetrau i'r gogledd-ddwyrain o ganolbwynt ei chyffordd â'r C0161 sy'n arwain at Ystad Llansbyddyd hyd at bwynt 280 o fetrau i'r gogledd-orllewin o ganolbwynt y gyffordd honno.

Llofnodwyd o dan awdurdod Ysgrifennydd y Cabinet dros yr Economi a Thrafnidiaeth, un o Weinidogion Cymru.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A40 Raglan to Llandoverly Trunk Road.

Restriction

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the length of the trunk road at Llanspyddid, Powys that extends from a point 650 metres north-east of the centre-point of its junction with the C0161 leading to Llanspyddid Estate to a point 280 metres north-west of the centre-point of that junction.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 84(1)(a) a (2) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, sy'n dod i rym ar 21 Mai 2018.

**THE A40 TRUNK ROAD (LLANSPYDDID,
POWYS) (50 MPH SPEED LIMIT) ORDER 2018**

The Welsh Ministers have made an Order under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, which comes into force on 21 May 2018.

The effect of the Order is to introduce a 50 mph speed limit on the length of the A40 trunk road at Llanspyddid, Powys that extends from a point 650 metres north-east of the centre-point of its junction with the C0161 leading to Llanspyddid Estate to a point 280 metres north-west of the centre-point of that junction.

During a period of 6 weeks from 17 May 2018 a copy of the Order and plan may be inspected, free of charge, during normal office hours at the Reception, Powys County Council, Neuadd Brycheiniog, Cambrian Way, Brecon LD3 7HR or may be obtained free of charge from the address below quoting reference number qA1320696.
