The Welsh Ministers, as traffic authority for the A483 Swansea to Manchester trunk road, in exercise of the powers conferred upon them by sections 1(1), 2(1), 2(2), and 124 of, and paragraph 27 of Schedule 9 to the Road Traffic Regulation Act 1984(1), after giving public notice of their intention to do so and after consultation with the Chief Officer of the Dyfed-Powys Police, make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A483 Trunk Road (Ammanford Road and Pontardulais Road, Tycroes Carmarthenshire) (Prohibition of Waiting, Loading and Unloading) Order 202- and it comes into force on ****202-.

2. In this Order—

“disabled person's badge” (“*bathodyn person anabl*”) has the meaning given in regulation 2(1) of The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000(2);

- (1) 1984 c.27; sections 1(1), 2(1) and (2) were amended by the New Roads and Street Works Act 1991 (c.22), section 168 and Schedule 8, paragraphs 17 and 18, section 1(1) was amended by paragraph 36(1) of Schedule 22 to the Environment Act 1995 (c.25). By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

Esemptiadau

5. (1) Ni fydd dim yn erthygl 3 yn ei gwneud yn anghyfreithlon i beri neu i ganiatáu i unrhyw gerbyd aros ar ochrau'r darnau o'r gefnffordd a bennir yn Atodlenni 1 a 2 i'r Gorchymyn hwn cyhyd ag sy'n angenrheidiol i alluog—

(a) person i fynd i mewn i'r cerbyd, neu i ddod allan ohono;

(b) nwyddau i gael eu llwytho ar y cerbyd neu eu dadlwytho ohono;

(c) y cerbyd i gael ei ddefnyddio mewn cysylltiad ag unrhyw un neu ragor o'r gweithrediadau a ganlyn:

- (i) gwaith adeiladu, gwaith diwydiannol neu waith dymchwel;
- (ii) symud unrhyw rwystr i draffig;

“the relevant position” (“*y safle perthnasol*”) has the meaning given by regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

“the A483 trunk road” (“*cefnffordd yr A483*”) means the A483 Swansea to Manchester Trunk road.

Prohibition of waiting at any time

3. Except as provided in article 5(1), no person may cause or permit any vehicle to wait on the sides of the lengths of the trunk road specified in Schedules 1 and 2 to this Order at any time.

Prohibition of loading and unloading at any time

4. Except as provided in article 5(2), no person may cause or permit any vehicle to load or unload on the side of the length of the trunk road specified in Schedule 2 to this Order at any time.

Exemptions

5. (1) Nothing in article 3 renders it unlawful to cause or permit any vehicle to wait on the sides of the lengths of the trunk road specified in Schedules 1 and 2 to this Order for so long as may be necessary to enable—

(a) a person to board or alight from the vehicle;

(b) goods to be loaded on or unloaded from the vehicle;

(c) the vehicle to be used in connection with any of the following operations:

- (i) building, industrial or demolition operations;
- (ii) the removal of any obstruction to traffic;
- (iii) the maintenance, improvement or reconstruction of the lengths of the trunk road; or

(d) the vehicle to be used in the service of a local authority or a water authority in pursuance of statutory functions;

(e) the vehicle to take petrol, oil, water or air from any garage situated on or adjacent to the lengths of the trunk road;

(f) the vehicle to be used for fire brigade, ambulance or police purposes; or

(g) the vehicle to stop when the person in control of it:

(i) is required by law to stop;

(ii) is obliged to stop in order to avoid an accident;

(iii) is prevented from proceeding; or

(iv) is acting upon the direction, or with the permission, of a police constable, police community support officer or civil enforcement officer.

(2) A person may cause or permit a vehicle to wait on the side of the length of the trunk road specified in Schedule 2 to this Order for so long as may be necessary to enable —

(a) a person to board or alight from a vehicle;

(b) the vehicle to be used in connection with any of the following operations:

(i) building, industrial or demolition operations;

(ii) the removal of any obstruction to traffic;

(iii) the maintenance, improvement or reconstruction of the length of the trunk road; or

(c) the vehicle to be used in the service of a local authority or a water authority in pursuance of statutory functions;

(d) the vehicle to take petrol, oil, water or air from any garage situated on or adjacent to the length of the trunk road;

(e) the vehicle to be used for fire brigade, ambulance or police purposes; or

(f) the vehicle to stop when the person in control of it:

(i) is required by law to stop;

(ii) is obliged to stop in order to avoid an accident;

(iii) is prevented from proceeding; or

(iv) is acting upon the direction, or with the permission, of a police constable, police community support officer or civil enforcement officer.

(3) Nothing in article 5(1) and 5(2) renders it unlawful to cause or permit a vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of the lengths of the trunk road specified in Schedule 1 and 2 to this Order for a period not exceeding 3 hours, being a period separated by an interval of at least 1 hour from a previous period of waiting by the same vehicle on the same day on the trunk road.

THE A483 TRUNK ROAD (AMMANFORD ROAD AND PONTARDULAI ROAD, TYCROES, CARMARTHENSHIRE) (PROHIBITION OF WAITING, LOADING AND UNLOADING) ORDER 202-

The Welsh Ministers propose to make an Order under sections 1(1), 2(1), 2(2) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit waiting, loading and unloading on the lengths of the A483 trunk road at Ammanford Road and Pontardulais Road in the County of Carmarthenshire, as specified in the Schedules to this Notice and introducing a zebra crossing controlled area in association with the waiting restrictions on Ammanford Road.

Waiting, loading and unloading is currently prohibited on some lengths of the trunk road concerned by virtue of the Trunk Road (Tycroes Square, Ammanford) (Prohibition of Waiting) Order 1968 which will be revoked and re-enacted by the proposed Order.

STATEMENT OF REASONS

The proposed Order is required to improve visibility on the lengths of the A483 trunk road at Tycroes, located to and from the access of the retail area and the Ammanford Road junction with Bryn Hafod and restricting parking over the proposed lengths detailed in the schedule.

The proposal is also required for the safety of pedestrians by introducing a zebra crossing controlled area associated with the waiting restrictions on Ammanford Road and is supported by the South Wales Trunk Road Agency and Carmarthenshire County Council.

The proposed Order will revoke the Trunk Road (Tycroes Square, Ammanford) (Prohibition of Waiting) Order 1968.
