The CG referred to his Plenary statement and explained that he was looking to appoint co chairs with a gender balance, followed by 9 commissioners with diverse skills/backgrounds/experiences/politics/geographies. They wouldn't need to be constitutional experts because the commission would benefit from a separate expert panel. The CG wanted the commission to look at constitutional developments from the perspective of how they impact on the delivery of services in Wales and how Wales can work better, including in terms of relationships within the UK. The commission would be launched towards the end of September or early October. The CG said he would welcome names of individuals who could be considered, but not Members of the Senedd as the commission would need to operate independently.

Andrew RT Davies said they could agree to disagree on the need for the commission and would continue to debate these matters on the floor of the Senedd, but he acknowledged that it was the Government's right to establish the commission and welcomed the engagement on commission membership. He asked a series of questions:

- Is it time limited? The CG replied that it will be (though it might make recommendations about a standing commission) – the original thinking was 18-24 months but this might need to be shortened to influence policy at UK level for example in light of a possible early UK Parliament general election – this would need to be discussed with the co-chairs.
- Is there a Conservative Party place on the commission or are we looking for a conservative thinker? The CG replied that he didn't want party nominations as such because commissioners need flexibility rather than being accountable to parties or constrained by pre-determined positions (it could challenge the Welsh Government's stance, for example).
- Will Commissioners be remunerated? The CG said they would be and I explained that although the rates had not been finalised, a reasonable comparator would be the Justice Commission – an average of 4 days per month and a day rate of £250.
- Are the terms of reference available? The CG said no.
- When will the co-chairs be announced? The CG said hopefully within the next fortnight.

Mr Davies said he had two people in mind and he agreed to provide names within the next few weeks. The CG emphasised that there are no guarantees of selection, and offered a further discussion if that would be helpful.
