

**GORCHYMYN CEFNFFORDD YR A470
(EGLWYS-BACH, GER TAL-Y-CAFN,
BWRDEISTREF SIROL CONWY)
(CYFYNGIADAU A GWAHARDDIAD TRAFFIG
DROS DRO) 2022**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 16A o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gallu cynnal digwyddiad Sioe Eglwys-bach ar gefnffordd yr A470, neu gerllaw iddi, yn Eglwys-bach, ger Tal-y-cafn, Conwy.

Effaith y Gorchymyn yw cyfyngu dros dro ar barcio a goddiweddyd gan bob cerbyd (ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys neu ar gyfer y digwyddiad) ar y darn o gefnffordd yr A470 sy'n ymestyn o bwynt 2 filltir i'r de o'i chyffordd â'r B5279 yn Nhal-y-cafn hyd at bwynt 2 filltir i'r gogledd o'r gyffordd honno. Bydd terfyn cyflymder dros dro o 30 mya neu 40 mya hefyd mewn grym, yn ôl yr angen, drwy gydol y digwyddiad.

Daw'r Gorchymyn i rym ar 13 Awst 2022 a bydd yn para am 1 diwrnod. Disgwylir y bydd y cyfyngiadau a'r gwaharddiad dros dro yn weithredol o 07:00 o'r gloch tan 19:00 o'r gloch ar y dyddiad hwnnw.

**THE A470 TRUNK ROAD (EGLWYSBACH,
NEAR TAL-Y-CAFN, CONWY COUNTY
BOROUGH) (TEMPORARY TRAFFIC
RESTRICTIONS & PROHIBITION) ORDER
2022**

The Welsh Ministers have made an Order under section 16A of the Road Traffic Regulation Act 1984, which is necessary to enable the Eglwysbach Show event to be held on or near the A470 trunk road at Eglwysbach, near Tal-y-cafn, Conwy.

The effect of the Order is to temporarily restrict all vehicles (other than those being used by the emergency services or for the event) from parking and overtaking on the length of the A470 trunk road that extends from a point 2 miles south of its junction with the B5279 at Tal-y-cafn to a point 2 miles north of that junction. A temporary speed limit of 30 mph or 40 mph will also be in force, as required, for the duration of the event.

The Order comes into force on 13 August 2022 and has a duration of 1 day. The temporary restrictions and prohibition are expected to operate from 07:00 – 19:00 hours on that date.
